As a speaker, I understand and agree that I shall provide a copy of my presentation, in the format indicated by SPFA, by the given deadline. I further understand, agree and consent for this presentation to be posted on the event website and available for download in .pdf format to be viewed by Convention delegates following the Convention.

I agree my presentation will be educational and informative in nature, and that my participation as a speaker or co-presenter at the SPFA Convention is not an open forum for me to make a "sales pitch" about my or any other company and/or product. I understand if I fail to adhere to these guidelines, I may not be invited to participate in any future SPFA events. I also agree to abide by the SPFA's anti-trust guidelines in the preparation and delivery of my presentation.
